I. CALL TO ORDER

• President Dale Rumberger (Dale R) called meeting to order at 7:05 PM.

II. ADMINISTRATIVE MATTERS & OFFICERS REPORTS

- Approval of Meeting Minutes
 - Dale R called for any corrections to the December minutes as posted on the website.
 - o Minutes were approved, no changes.

III. SUPERVISOR REPORTS

• Springfield District Supervisor Pat Herrity

Dale R states that Supervisor Herrity had a conflicting meeting tonight.

• Mount Vernon District Supervisor Dan Storck

o I wanted to start off by congratulating you all for your resiliency and still holding meetings during the COVID 19 pandemic. The South County Federation (SCF) has passed the test! This is a remarkable time for all of us, even though it's been, by far, one of the hardest years that I, personally, have had to experience; and it's been one of the hardest years for Fairfax County residents, and frankly the entire world. I have been especially proud to serve as your district supervisor this year, and want to thank you all for your continued engagement in the midst of such a trying year.

Despite our challenges, I can confidently say that we have accomplished many things this year in the Lorton and South County area. Accomplishments and updates include:

 Insurrection at the Capitol – It's been a rough week, but we got through it, and I'm thankful that we're here and that we kept our republic. The saddest thing is that Officer Brian Sicknick lived in our area in the Saratoga community. We will look for ways to honor



him in some significant way, but for now we need to not impede his own family's grieving.

- 34th Annual MV Town meeting The meeting on February 6, will be all virtual and may be followed on Channel 16 or Facebook, and starts at 9 AM. We will feature a "virtual flying tour" of all that is happening in the District, and to get an idea of what the future might look like in our area in 20 or 30 years.
- Ocid Vaccine program The county has now opened the vaccine to group 1B (people over 75 and frontline essential workers such as police, teachers, etc). I sent out a newsletter with the registration form as well as the vaccine hotline 703 324-7404. You can also find the information on our website. We got more than 200,000 calls in 24 hours, and so it's probably a better idea to register on line.
- o Waste Management Inc (WMI) most issues are related to the landfill, and we'll be considering some resolutions tonight. Whether or not they pass, be assured that we are working with county staff to get a basic understanding of the FCPA plan. It is a major focus for us to work with the corporate authority and our legal staff so we can come up with a basic legal understanding of at least the WMI portion, and to ensure that FCPA-to-WMI decisions go through the community first. I hope to wrap it up by midway this year.
- o Residential and commercial parking we recognize that we need to adhere to our basic parking laws; and I encourage you to contact your police station's one dedicated parking issue police officer. Make sure that



he is aware and updated to the situation in your neighborhood.

- Laurel Crest Drive Great news is that, due to the advocacy of Pam Nickson, Bill Thompson and the SCF, the Laurel Crest portion (related to the middle school) will be completed! We got the Laurel Crest Drive money released. The letter for bond close-out is completed. There's still one issue with VDOT's acceptance of Laurel Crest Drive, and which should be resolved when the FCPS meets them to discuss necessary road improvements such as sidewalks.
- O Hooes Road needs a Sidewalk We need to address the danger of going down parts of Hooes Road and we need a sidewalk. I've been working with Pat Herrity on this. Of course, there are always more projects than funding; but my approach is to triage the most dangerous roads as the first to fund.
- Concerns regarding Break-ins We've been hearing concerns about this. I've asked Nick Rinehart to share some data points with you on this to consider. Is it really a new problem or is it just perception from a cluster?
- O Alpine X There is no new news. We continue to work with county Staff, and they will present to the SCF, to determine ways and means of how to meet the needs of the community, while still providing robust opportunities for jobs. I'll continue to interact with all of you to generate the best outcome for everyone. You can read some general information at:

o QUESTIONS:

- Ken Frye asked about the status of the county finances, and also, he's heard talk of the possibility of police overtime. ANSWER: We had a budget review meeting today, which you may view on line at https://www.fairfaxcounty.gov/boardofsupervisors/board-supervisors-budget-policy-committee-meeting-jan-12-2021. The County is relatively okay financially, and we are pretty much on track with expenditures. The Mid-year adjustments are not too bad, so our net adjustment is about \$5 million.
- Casey Whitmarsh asked about a small business that wants the vaccine. Also, where do home care agencies fit in with the vaccine program? ANSWER: I think that home care providers fit the requirements for the current group. I think that they should qualify now because they provide direct patient care; so tell them to reach out to the Hotline number. As for the business, send an email to our office and we'll get the answer for you.
- COMMENT Dale R highly praised the value of the town hall to all. He also asked the Supervisor if he can possibly attend the SCF meeting on April 13 to focus on the county budget.



ANSWER: I'm happy to come; but there is a Board of Supervisors (BOS) meeting that day; so the risk is that sometimes the board meeting runs long.

• <u>Mount Vernon District School Board – Karen Corbett – Sanders</u>

- Dale R states that Ms. Corbett-Sanders has a conflicting meeting. He will ask for written input from her.
- o This Saturday, educators will start getting their Covid shots out of the 40,000 doses allocated by the governor, and this will happen over a 4-week period.

• Springfield District School Board – Laura Jane Cohen

No input received

• Fairfax County Park Authority (FCPA) – Linwood Gorham

- o I'm very proud to announce that we held the very first equity-sensitive park planning meeting in the Mount Vernon Magisterial District for the Northfield Park. It was multi-lingual and all virtual, and it almost looked like we knew what we were doing. :)
- o <u>Garden Plots initiative</u> This is going very well, and I'll leave it to Wes to report on that.
- Bathroom at the Central Green Linwood described a letter from the SCF strongly objecting to the design and placement of the bathroom and the tot lots. The biggest issues are related to the bathroom; and so Kelly Davis, the landscape architect for the FCPA is on the call today.



- Dale R detailed 3 major objections, backed up by the strong support (not recorded in these minutes) of the entire SCF EXCOM:
 - > The location of the bathrooms
 - The placement of the tot lots in the center of the common area (although Dale R said that he came to understand, after sending the letter, that the tot lots can easily be repositioned).
 - ➤ The proposed design and coloration of the bathrooms
- Kelly provided some background. "I went to the Architectural Review Board (ARB) in 2015, and was very optimistic of getting the whole package (the bathroom plus 3 picnic shelters) approved. I showed them the Burke Lake brick bathroom design. To our surprise, the ARB did not want another brick building in the historic district. They did not want another brick building to avoid confusing it with a real historic building, so we decided to drop that. They wanted a low-profile design with coloration to play off the farm surroundings, and the roof pitch to match the turkey barn. They sent me some building designs that they would approve and which were modern, low-profile etc. After that, we dropped any plan for the bathrooms so that we could move ahead with the picnic shelters. This summer, we again picked up the bathroom design issue, and I chose from among the ARB preferred designs and gave



it to the architect".

COMMENT Dale R: My frustration is that I look at the ARB guidelines and two of them in particular stand out: "Designing new, compatible structures that don't create a false sense of history by making them look older than they are", and believe me, that doesn't; and also "Designing new construction that is compatible and complementary with the existing historic district." When I looked at the coloration, the design, there is no way that *that* bathroom would be seen as historic, no way would it be seen as compatible or complementary. Also, the fact that it is easily seen from Lorton Road (is an negative factor), although others suggested that it may be there in order to surveille it more easily. That area of Lorton Road and the turnoff to Workhouse Road has become a major cut-through for large, heavy duty trucks. I can see where that could become a pull off for truck drivers to take a real quick "pit stop". But most specifically, when you see how it doesn't fit with the character of the rest of it; and then when you look at the turkey barn, my concern is how do we fix this? Because if we create a big deal about it, we could end up not getting it forever. That's not what we want, but at the same time, we don't want a bathroom forever that doesn't fit in with the character of the site and what's going in around it. For instance, across the road at the animal shelter/police station, they have changed the coloration of the brick and they have the arches. Same thing at the Community Center



and Library. So I'm thinking that we'll have to go to Laura Arsenaux (Fairfax County Planner) and ask her how do we fix this?

ANSWER/Final Comments: Kelly said we can submit to the February ARB meeting. Dale R noted that we'll post the designs on our website for comments. Linwood asked how much time delay a change in design would take. Kelly said maybe 6 months or so. Dale R opined that rushing to get something in, that the community doesn't like, isn't the best. Nick says that people already are going out to the Central Green, so what about providing port-a-johns. Kelly says they pull them during the winter, but when the picnic shelter reservations start, then the port-ajohns will go back. Linwood pointed out that the Central Green is in a Historic District, while the buildings that we have cited for comparisons are not. Larry says that, per the MOU, this site is not in a Historical District, although it is treated as such, so we should check the overlay. Dale threw in a quick question about what's going on with the barn. Kelly will check with Ed about it; but states that the barn will stay, and not be torn down.



IV. LEGISLATIVE REPORTS

- Congressman Don Beyer, 8th District, is represented by Julia Kravitz, Outreach Coordinator. <u>Julia.kravitz@mail.house.gov</u> "We are having a telephone townhall next week on Martin Luther King Day, and I will circulate the information for the townhall once it is formally announced later this week."
- Congressman Gerry Connolly, 11th District, is represented by District Director, Marlon Dubuisson:
 - Stephanie will take over as the Prince William County outreach representative.
 - O The first bill passed this year was the Federal Risk and Authorization Management Program Authorization Act of 2021 (FedRAMP Authorization Act). The bill establishes the Joint Authorization Board to conduct security assessments of cloud computing services and issue provisional authorizations to operate to cloud service providers that meet FedRAMP security guidelines.
 - "Congressman Connolly and I want to thank everyone for reaching out to check on us (during the Capitol riot).
 It means a lot to us."
 - OCOMMENT: Dale R requests a double check be done on the stimulus bill regarding transportation projects such as the CSX bridge, the Long Bridge, etc. because all those projects are important to us and may have been tied up in legislation; and we don't know where they are right now.

- Delegate Tran, 42nd District is represented by legislative aide Rodrigo Velasques.
 - o Update on Covid-19. Delegate Tran and other delegates held a town hall meeting that included Covid information last week. We have put a lot of information on our website. Click on the Newsletter at: https://kathyfordelegate.com/enewsletter. . There you will find a lot of the FAQs that we receive. We are still waiting for VDH to provide us with more information about the vaccine plan. Tomorrow starts the Legislative Session, which will be completely virtual. Meeting in person is not possible right now because of Covid; but if you'd like to meet virtually, you can make an appointment with me or Del. V. COMMITTEE REPORTS

• <u>Transportation, Peter Weyland/Dale Rumberger, Co-Chairs</u>

 Deceleration lane on Lorton Road at the entrance to the Laurel Hill Park's Central Green. We request an expansion of the roadways due to a likely backup of people going into the park.



- Pohick Rd sidewalk Running from Rte 1 to Lorton Station Blvd, the estimate is \$2.5 million, of which \$1.5 million is available, and FCDOT is working to complete the scoping process.
- o Construction vehicles parking in neighborhoods Dale did send a letter out of concern for two neighborhoods, Laurel Hill and Marty's neighborhood around Sanger Place. He then said, "The frustration is that this isn't a question about enforcement, as Dan has said. Number 1, there is only *one* parking enforcement officer per magisterial district, so there's no way that they can cover all the territory. And number 2, from my own time dealing with parking problems, is that the parking enforcement officer would typically be reassigned (for instance) to replace an officer who was going to be gone for 60 days of physical rehab, so that the police don't have to draw down their manpower from any place else. So it's not an enforcement position that's available on a 24/7 basis. And then, number 3, I'm seeing that at Gunston Cove Road, they are going to have a meeting on the 26th of January because the business owners up there want something done about commercial parking on Gunston Cove Road. All at once there's a Jan 26 meeting and there are going to be restrictions on Gunston Cove Road, and residents are saying that in two areas, commercial parking is putting residents in danger. So it's a safety issue, a property issue, and eyesight issue; and there's nothing being done because it's an enforcement issue. I think part of this is within the laws. I think there needs to be a better connection within our district to our state legislators to see if this can be solved, rather than kicked down the



road each time and saying it's somebody else's job to fix it. This has gone on way too long! From my perspective, the Laurel Hill issue has been going on for at least 8 months. And I first got a note from Marty about his neighborhood 3½ years ago! We need our elected leaders to move on this. I'm going to report this and ask our legislators to provide regulatory relief in the form of not having commercial vehicles blocking citizens' utilization of the roadways."

- <u>Fairfax Connector Routes</u> A newsletter survey has been sent to every address in Fairfax with the theme of "Help shape the future of bus service for our area."
 There's a Feb 19th deadline, and there's a survey link at www.fairfaxcounty.gov/survey/connector/TSP, and a phone link for suggestions: 703-337-7200
- O Hooes Rd pathway has already been discussed by Supervisor Storck, and we'll be keeping that on the radar. Dale R added that for anyone interested in asking Supervisor Herrity about the design and construction of the Hooes Road pathway to connect the Fairfax County Parkway with Silverbrook Road, the contact in Herrity's office is Peyton Onks, 703 451-8873 and/or Peyton.Onks@fairfaxcounty.gov
- Widening Pohick Rd This \$51million project is right on the edge of our district.
- Long Bridge is a long-term plan for 2030 which will add lanes across the Occoquan and have impact along the Rte 1 and Furnace Road area.
- <u>Fairfax Peak</u> We'll be following the traffic egress impact, and whether there will be one or multiple access points.



- O Power poles too close to roadways Gunston Rd in Mason Neck area has several power poles too close to the road, some as close as 2 ft from the roadway in a 45mph speed zone, and we've asked Dominion Energy and VDOT to take a look at them. There have been 3 recent incidents of cars hitting these poles and knocking out power to Mason Neck. We're asking them to put up a guard rail or realign as many as 7 poles.
- Alban Rd dip (just north of Pohick Road and near the small bridge) is dangerous and would like someone to look at it.
- O Dale R recognized and thanked Sally Kidalov, who is the transportation rep in Dan Storck's office, and now moving over to Supervisor Walkinshaw's office. She has been very helpful. For instance, she posted the snow plow website and the pot hole website: https://www.fairfaxcounty.gov/news2/heres-how-toreport-those-pesky-potholes-2/
- How to Report those Pesky Potholes They are a way
 of life on the roads, especially as temperatures fluctuate
 this time of year. Please report potholes you encounter!
 Your car will thank you. While the Virginia
 Department of Transportation (VDOT) maintains most
 primary and secondary roads in the County, you can
 look up who maintains every road.

VDOT's online reporting tool makes it easier to pinpoint exactly where you see a pothole. You can also report potholes directly from your mobile device and include images.



- You can also call VDOT at 1-800-FOR-ROAD (1-800-367-7623) to report potholes or to ask who maintains a road.
- O QUESTION: Keith Shovlin asked about the widening project at Silverbrook Rd / Southrun Road. Is the expected completion date still June? ANSWER: We have no additional updates, because the road access is part of the development access.
- Speed humps design on Southrun Road Dale R asked Nick Rinehart to check on the status because we're awaiting final approval. Dale also hopes to have FCDOT attend the February SCF meeting to provide HOAs with information on how to request and obtain traffic-slowing humps in neighborhoods.

• Public Safety, Jonathan Kiell, Chair

• Wes has been unable to attend today, but we recognize his contributions/leadership on the Garden Plot Initiative and the Bartlett House and the Middle School property. That's why some of that AAAACo money in looking at stormwater drainage, etc are important because they both were places for potential garden sites adjacent to centers of population.

• Education – see school board member report



• Land Use, Nick Firth, Chair

- Shoppers is scheduled to open "something" in the 4th quarter of 2021.
- Panera I received an email from them today and they are trying to move things forward again, so we might see some more updates on that in the near future
- Showroom on Workhouse Road It is now open if anyone wants to go and take a look.
- Complex new application This one may be controversial, and will be coming to the Feb 23rd Land Use meeting regarding the building of eight single family homes. Keith Shovlin says that the land is within the boundaries of their HOA so they will be meeting with the owner soon. The property is right up against power lines; and it's on Hooes Road which is already congested with a lot of traffic. Dale R added that the developer wants to be able to tap into all of the various connections for the Southern Oaks HOA's open space and to use this open space to mitigate against the development conditions in meeting county zoning on that piece; and they (Southern Oaks) were opposed to that and not wanting them to do that; and there was a financial offering there that didn't mean anything.



o Resolution on Methane Emissions, Lorton Landfill.

Now, therefore, be it Resolved, that the South County Federation states that it is imperative that the county staff and agency Team led by Kirsten Munz be directed to immediately form an interdisciplinary team, including representatives from DEQ to evaluate the likely sources that are causing the excess methane emissions; determine what possible remediation measures must be taken to reduce the methane emissions to acceptable levels which can be sustained for the period of time necessary to insure that human access to Overlook Park can be afforded the citizens of Fairfax County at the earliest opportunity.

Larry Clark presented the Resolution, which is primarily designed to stimulate/motivate a response. Larry cited the extended period of time over which we've been working with this large, multidepartmental team, and asking over and over, without getting a response.

A **Motion** was made and the **Resolution** was approved.



 Resolution on Additional Parking for Overlook Park (Lorton Landfill).

Now, therefore, be it Resolved, The South County
Federation states that it is imperative that the county
staff and agency Team led by Kirsten Munz be directed
to study alternatives for additional parking at
Overlook Park, to include as part of this process, a
public meeting to provide the planning options and to
receive community input; the SCF would be happy to
host or co-host such a meeting in the local community;

That cost not be a disqualifying factor, but that costs of alternatives be computed so that alternatives can be evaluated on equal terms;

That the Team be instructed to consider neighboring parcels of land that could be purchased from WMI and converted into parking areas, notably the former 9-acre tentative recycling parcel directly across from the entrance to Overlook Park;

That the Team present the results of their research to the office of the Mount Vernon Supervisor within 90 days of being tasked to conduct the study in a public forum where the results can be analyzed and questioned by the South County Federation and the citizens of Fairfax County.

That the results of the study above will be posted on the Lorton CDD Landfill Closure page of the county's website.



Larry Clark explained the resolution, and after a brief discussion, the **Motion** was made and the **Resolution** was approved.

Resolution on Inventory of Amenities for Overlook Park (Lorton Landfill).

Now, therefore, be it Resolved, The South County Federation states that it is imperative that the county staff and agency Team led by Kirsten Munz be directed to develop a comprehensive list of all the amenities required by SEA-1 and contained in the Site Plans; to include as part of this process, a public meeting to provide the planning options and to receive community input; the SCF would be happy to host or co-host such a meeting in the local community;

That the list be made public for review and analysis and that the results of the study above will be posted on the Lorton CDD Landfill Closure page of the county's website.

That no "trade-offs" of amenities required by SEA-1 and contained in the Site Plans be "traded-off" through the Zoning Interpretation or any plans developed by the FCPA prior to a 30-day public review and comment period conducted under the auspices of the Mount Vernon District Supervisor's office.



Larry Clark said, "What we're asking for here is for someone in the county, hopefully from the LDS, to go through each page of the site plan and physically inventory all the amenities that are required there. I had asked earlier why this had not been done, and the answer I got was that it was too hard. We feel that it is not too hard and it needs to be done, and we feel that this is an imperative to be sure that all the amenities are accounted for, and this will also allow for the costing of the amenities that may be candidates for trade-off, thus allowing for an economically advantageous negotiation.

No questions or comments were made. A **Motion** was made and the **Resolution** was approved.

- AAAA junk company stormwater monetary penalty and use of penalty at USAR site or alternative -Presentation by Charles Smith, Fairfax County Stormwater Planning Division
 - Overview of how the monies were determined The AAAA Junk was penalized because they filled in a flood plain and put in asphalt millings, when they had no permission to do this. They were cited and are being required to remove all the millings and restore the flood plain. In addition, they had to pay for all this restoration and were given a penalty of \$125K . All this was done through Land Development Services (LDS). They asked us to become involved so that we could locate a project where we could apply the money for a water quality benefit somewhere



nearby the actual site where the impact to the flood plain had occurred.

- Potential project locations
 - 1. USAR Regional Pond We had previously identified the urban search and rescue Regional Pond site, which is an old defunct pond that was built by the federal prison, immediately upstream from Occoquan Regional Park. The old pond is breaching and the goal is to go in and create a pond that provides benefits in this area by converting the breached farm pond to a regional level 2 pond. It would provide detention for about 61 acres of currently untreated drainage area, and protect receiving streams in Occoquan Regional Park from erosive flows and sedimentation. The AAAA Co funds would be applied toward making the new stormwater detention facility a level 2 pond versus a level 1 pond to provide much greater water quality benefits
 - 2. Laurel Hill Park/South County Middle School nearby pond Mr. Smith said that actually there are two ponds near the school. "One pond is maintained by the county and was actually built as a stormwater pond during construction of the adjacent subdivision. It is under county easement and is on private land adjacent to FCPA land. It's a dry pond and there is no standing water in it. The other pond, which is closer



to the school is actually not a stormwater pond at all. We call it a farm pond and it is left over from the time of prison use. We would not see this area as a storm water project, although certainly it could be used for other purposes."

• QUESTIONS:

- ➤ Dale R asked if the AAAA money can only be used for water quality projects. ANSWER: Yes, I believe so.
- Larry Clark: When Wes sent you the original package, he had a bunch of pictures of drain fall, and more. Are these not seen as storm water modifications or improvements? ANSWER: So, the key would be this: ... so far as the dry pond, if any work needs to be done on that, as far as maintenance activity, that would be the county's work burden. Within the five-year cycle of inspection for deficiencies noted, the county is obligated to take action. So, within this particular pond, there is no benefit to apply the AAAA dollars because I would call it your normal maintenance cycle. The wet pond is not part of our maintenance system. The danger of the county doing anything with that pond is that we would then assume responsibility for managing it over



time. So the wet pond ... well, I could take a look to see if there is outfall over the old driveway there, and we might be able to look at doing something." Charles then said he would walk this area between the old driveway and Silverbrook Road on Wednesday; and that he should be able to get an email back to all of us regarding whether or not this area can be used for this project. He will also continue a follow-up with the FCPA to see if they want him to look at any other sites.

- <u>Update from LDS on Workhouse Arts Center</u>, Buildings 13 and 15. They have design proposals that they would like to share with the whole community.

Dale Rumberger adjourned the meeting at 9:45 pm.
