



## Dues Notice and Membership Information

### ***Membership Dues***

Membership dues for the South County Federation (SCF) are due and payable as of January 1. As of April 1, 2006, only associations who are current with membership dues will be allowed to vote at general membership meetings. Make check payable to "South County Federation."

- One Time Permanent Membership Fee **\$50.00**
- Annual Membership Fee **\$25.00** (At such time as a member decides to become permanent you may pay the One Time Permanent Membership Fee)
- Individual One Time Permanent Membership Fee **\$20.00**
- Individual Annual Membership Fee **\$10.00** (At such time as a member decides to become permanent you may pay the One Time Permanent Membership Fee)

### ***Membership Application***

The enclosed SCF membership application must be completed and returned along with your payment of dues. Please provide as much information as possible, including e-mail addresses and telephone numbers, as this will help us to better communicate with our members and the South County community. Completed membership application and annual dues should be mailed to the attention of: South County Federation (SCF), P.O. Box 442, Lorton, VA. 22199, or delivered in person the SCF Treasurer at one of the SCF meetings. The SCF meets monthly on the second Tuesday of the month at 7:30 PM at the South County High School.

As officers and addresses frequently change, it is incumbent upon the member association to keep the SCF apprised of all contact information modifications, as well as changes for designated association representation to the SCF, throughout the year. All changes to designated association representation to the SCF must be written and signed by the Association President, as reported in the membership application.

### ***New Associations***

Any eligible citizens' association; civic association; or homeowners' association that is located within Southeastern Fairfax County area is eligible for membership in SCF. The membership area is as follows: boundaries extended to the south to the Occoquan River; to the east to the Potomac River, to the north (from east to west) to the southern boundary of Fort Belvoir, the Fairfax County Parkway, I-95, the Franconia Springfield Parkway, the Fairfax County Parkway (to include and portion of the Mount Vernon Magisterial District on the north side of the Parkway), Lee Chapel Road to Route 123, to the west, a line drawn from the intersection of Lee Chapel Road & Route 123 to the head of Sandy Run, Sandy Run to its mouth at the Occoquan River. Interested members of the community may also apply for individual membership in the SCF and would be eligible for voting privileges (with the exception of Land Use matters) in the non-aligned caucus.
